



**City of San Dimas Parks and Recreation Department  
Youth Assistance Scholarship Program (YASP)  
Eligibility and Application Process**

The City of San Dimas Parks and Recreation Department's (SDPRD) Youth Assistance Scholarship Program (YASP) is available to qualifying youth wanting to participate in the Kids Fun Club or Teen City program. In order to qualify, families must complete an application and provide documentation of household income and residency as listed below.

\* Shirts and excursions are not eligible for scholarship assistance.

**A. ELIGIBILITY REQUIREMENTS**

- City of San Dimas Resident
- Limited to participation by children 17 years and younger
- Meet income limits, based on Maximum Allowable Gross Household income per HUD income requirements:

- PROOF OF INCOME MUST BE PROVIDED, OR THE FAMILY IS NOT ELIGIBLE.
- Submitting the application does not guarantee approval.

**B. SCHOLARSHIP BENEFITS**

- Approved scholarships are available and awarded on a first come, first served basis.
- Weeks 6-10 (July 17, 2023 - August 18, 2023) of Kids Fun Club and Teen City are eligible for assistance.
- Maximum amount shall not exceed \$100/per week for each child up to five weeks.
- Scholarship eligibility expires six (6) months after approval, unless income is recertified.

**C. APPLICATION PROCESS**

1. Submit completed YASP application with copies of requested documents a minimum of two weeks prior to start of the program.

2. Upon review and approval, you will be notified via email. Please allow a minimum of two weeks for processing.
3. The scholarship is non-transferrable. If the child cannot attend or cancels, no scholarship amounts will be credited back to the applicant's account.

**D. DATES TO REMEMBER**

- The scholarship process can take up to two weeks. In order to expedite the processing of your application, please submit all requested paperwork together.
