#### *Latest Updates:*

##### *Local:*

- Bobcat Fire update: the fire is at 113,986 acres at 55% containment. Crew, engines, equipment and aircraft work in coordination to build holding lines, plumb the lines with water, and while firing aviation assets slow the movement of the main fire. A focus of efforts today and tomorrow will be securing the west side of the fire before winds shift to the northeast Sunday
- Foothill Gold Line update: this week construction authority and KPJV staff inspected initial sample form panels developed to create a unique design pattern on columns of future Gold Line bridges over Route 66 and Lone Hill Avenue in Glendora.
