Local:

- Something very exciting and dare we say ELECTRIFYING has come to the City of San Dimas. In partnership with Mobile Source Air Pollution Reduction Review Committee of the South Coast Air Quality Management District, the City is pleased to announce five publicly accessible electric vehicle charging station stalls. - Starting January 4, 2021, and continuing through March 31, 2021, the intersections of San Dimas Ave./Bonita Ave. and San Dimas Ave./Commercial St. will have intermittent lane closures to perform street improvements. Small businesses both profit and non-profit can review eligibility, prepare documents and apply. Applications open December 30 – January 8.

County:

- Los Angeles County has recently updated their protocol for Places of Worship. To view the updated protocol click here, [Reopening PlacesofWorship.pdf \(lacounty.gov\)](#). Places of Worship are permitted to offer faith-based services, or otherwise allow access for faith-based practices, indoors and outdoors, provided that strict physical distancing is followed, which requires a minimum of six feet between persons from different households. Face coverings or masks that cover both the nose and mouth must be worn at all times while on site. Places of Worship are strongly encouraged to continue to hold faith-based services outdoors to the maximum extent practicable.

State:

- The CDC has accepted Advisory Committee on Immunization Practice's (ACIP) recommendation for the next phases of COVID-19 vaccination. To view the essential worker categories in detail visit, [Essential workforce - Coronavirus COVID-19 Response \(ca.gov\)](#).
 - 1B – non-health care frontline workers and people ages 75+
 - *First responders, correction officers, public transit workers, education sector and child care workers.*
 - 1C – People with certain underlying medical conditions, people ages 65-74, and other essential workers not included in phase 1B
 - *Transportation and logistics, water and wastewater, food service, shelter and housing(construction), finance(bank tellers), information technology and communications, energy, legal, media, public safety(engineers), and public health workers.*
- California DMV has been extended until January 4th. Persons with scheduled appointments will be notified and rescheduled for a later date.
